
ORDERED and ADJUDGED that:

Plaintiff, International Engineering Services, Inc., whose address is 265 North Ivey Lane, Orlando, Florida 32811, shall have and recover from Defendant, Pat Cook Construction, Inc., whose address is 1904 Manatee Avenue West, Suite 300, Bradenton, Florida 34201, the principal sum of \$9,450.00, together with prejudgment interest in the amount of \$731.32, costs of \$370.00, and attorney's fees of \$1,845.00, all of which total \$12,396.72, which shall bear interest at the legal rate provided in Florida Statutes §55.03 from this date until fully paid, for all of which LET EXECUTION ISSUE.


