**FINAL JUDGMENT BY DEFAULT**

**THIS CAUSE** coming on to be heard before the Court on this day, pursuant to the Plaintiff's Motion for Final Judgment by Default in favor of ANGLE TRUSS, INC., a Florida corporation, and against the Defendant, PAT COOK CONSTRUCTION, INC., a Florida corporation. This is an action for Breach of Contract. Service of Process was effected upon the Defendant on January 16, 2013. On December 13, 2013, a default was entered by the Court for failure to retain new counsel within the time required by entry of Order of the Court. The Court having reviewed the pleadings and otherwise being fully advised in the premises, it is thereupon:

**ORDERED and ADJUDGED** that:

1. The Plaintiff's Motion for Final Judgment by Default is hereby GRANTED.
2. A Final Judgment is hereby entered in favor of Plaintiff, ANGLE TRUSS, INC., a Florida corporation, and against the Defendant, PAT COOK CONSTRUCTION, INC., a Florida corporation.
3. Plaintiff, ANGLE TRUSS, INC., shall recover from the Defendant, PAT COOK CONSTRUCTION, INC., the amount of \$64,581.55, which amount includes the following:

(a) Remainder of Payment due on the Contract:	\$38,063.08
(b) Accrued Interest (9/17/2011-3/26/14):	\$14,024.99
(c) Accrued Interest (3/27/14/-4/28/13):	\$ 600.64
(d) Attorneys' Fees (including anticipated):	\$ 6,432.00
(e) Collection Costs (exclusive of Attorneys' Fees):	\$ 1,368.98
(f) Interest (\$18.77, per day) 3/27/2014-10/30/2014	\$ 4,091.86
<b>TOTAL (October 30, 2014):</b>	<b>\$64,581.55</b>

For which sum let execution immediately issue.

4. Statutory interest in accordance with Florida law shall accrue pursuant to Section 55.03, Florida Statutes, legal interest or interest at the contract rate, whichever is less, on the total amount due shown above from the date hereof until collected in full.

5. Plaintiff, ANGLE TRUSS, INC., has an address of P. O. Box 1091, Tavares, Florida 32778.

6. Defendant, PAT COOK CONSTRUCTION, INC., has a last known address of: 1904 Manatee Avenue West, Bradenton, Florida 34205-5860.

7. It is further ordered and adjudged that the Defendant, PAT COOK CONSTRUCTION, INC., shall complete Form 1.977(a) (Fact Information Sheet) and return it to the Plaintiff's attorney, or to the Plaintiff if not represented by an attorney, within forty-five (45) days from the date of this Final Judgment, unless the Final Judgment is satisfied, or a motion for new trial or notice of appeal is filed. **The Defendant should NOT file the completed Form 1.977(a) with the Court.**

8. Jurisdiction of this case is retained to enter further Orders that are proper to compel the Defendant(s) to complete Form 1.977(a) and return it to the Plaintiff's attorney or the Plaintiff if the Plaintiff is not represented by an attorney.


9. The court specifically reserves jurisdiction of this entire matter to enter any further Orders that may be equitable, appropriate and just.
